Dear member federations of the FMJD

The General Assembly 2015 has accepted a proposal for the World Championship International draughts on 100 squares in 2017 to be played with 84 players. Every member of FMJD has the right to participate with one (extra) player in this World Championship. 20 federations can send a player who can participate with costs for hotel and meals paid by the organisation. All other member federations may participate with a player who has to pay for his own costs for hotel and meals.

The following federations have the right to send a player with costs paid by the organisation.

ALL the other federations have the right to send a player with hospitality costs paid by themselves or by their federation.

The right for this places is only valid if the federations have paid their membership fees. If the membership fee of 2017 is not paid before March 31,2017 the federation loses this right for their player to participate.

All federations are kindly requested to fill in the attached form and scan it and return it to the FMJD before February 28th.

Also, if you are not going to participate you are asked to fill in the form as the **FMJD needs your confirmation of membership for a possible IOC recognition.**
